WHEREAS, the Drainage Board (the "Board") for the Millers Creek Ann Arbor Drain Drainage District (the "District") has designated the area to be served by the Millers Creek Ann Arbor Drain and its "MCAA Pepper Pike 5626.01" drain project; and,

WHEREAS, the Board authorized the contract in July 2019 in the amount of one hundred fifty thousand (\$150,000.00); in August 2019, the board authorized an amendment where the scope of work was modified to provide monitoring for five (5) years, increasing the total compensation by eighty five thousand dollars and ninety-three cents (\$53,045.93); and

WHEREAS, the scope of work was modified again for design and oversight of additional four (4) instream structures, modification of four (4) existing structures, provision of paths for offsite drainage to access the stream, and other improvements; and,

WHEREAS, the Board has received and approved a proposal amendment, specifications and an estimate of the cost for the additional work within this District in the amount of thirty-five thousand dollars (\$35,000.00).

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Statutory Drainage Board hereby authorizes its Chair to sign documents necessary to amend the contract between the MILLERS CREEK ANN ARBOR Drainage District and Orchard, Hiltz, McCliment, Inc. increasing the total amount of the contract by thirty-five thousand dollars (\$35,000.00) making the total amount of the contract not to exceed two hundred seventy thousand dollars (\$270,000.00).

 Addendum 2 – Repair/Modification Improvements

Dear Mr. Sheehan:

During the summer 2021 rain events, it has become clear that modifications to the Miller's Creek stream restoration project will be beneficial to ensure a stable stream channel is established. Proposed repair work slated for fall 2021 includes the addition of four instream structures, modification of four existing structures, providing paths for offsite drainage to access the stream, and other improvements. The following tasks are proposed to perform the stream modification Construction Administration and Engineering.

Task 1: Construction Administration

Under this task, the OHM team will assist with the award of the project including coordination with WRC and the City of Ann Arbor. Specific work efforts include:

1. Prepare a change order for the modifications, including review of existing insurances and bonds. Review the completed documents and provide to WRC for execution.
2. Notify parties of up to four progress meetings. Conduct the progress meetings, prepare, and distribute meeting minutes to attendees.
3. Prepare a log form for all required contractor's submittals (shop drawings, catalogue cut sheets and materials certification letters).
4. Review required submittals and distribute to WRC and contractor.
5. Prepare weekly e-mail progress updates to WRC staff summarizing project progress, construction issues and anticipated schedule. Hold bi-weekly progress meetings (assumed four progress meetings) and distribute minutes for those meetings. We have assumed 5 weeks of active construction with one progress meeting before and after to set up construction and follow up on restoration.
6. Prepare bulletins, work orders, progress payments (assumed two progress payments) and change orders (assumed two change orders) based on the observed construction progress.
7. Upon notice by the contractor, complete a preliminary walkthrough of the overall project with WRC staff at substantial completion, prepare substantial completion notice and develop a punch list for submission to the contractor.
8. Once the contractor has completed punch list items, we will complete a final inspection and provide WRC with a recommendation for final payment to the contractor.



Deliverables:

- Executed change order
- Progress meeting notes
- Progress update e-mails and four progress meeting minutes
- Monthly estimates (assumed two progress payments) and two change orders
- Preliminary walkthrough punch list
- Restoration progress updates
- Final inspection walkthrough notes and recommendation for final acceptance

Task 2: Construction Engineering

Under this task, the team will perform construction observation. Specific work efforts include:

1. Construction observation will include full time on-site observation for stream structure (assumed to be a duration of 4 days) and part time observation for grading and other associated work elements (assumed to be a duration of 21 days).
2. OHM Advisors will be an onsite presence (assumed to be two to four hours per day) that will be a friendly face for the residents and stakeholders to help minimize the construction impacts, answer questions, and remain a liaison between the contractor and the community at large.
3. Complete Construction Daily Reports (CDRs) for each site visit. The CDRs will be prepared electronically. CDRs will document the work conditions, who came to the site, the pay items that applied to the work that day, a chronology of what was performed onsite that day, a list of the materials brought to the project and the results of their inspections, a narrative of key tasks that occurred that day, sketches with dimensions and elevations of work performed, and list any utility damage or visitors to the site. The CDRs will be input into a computer program that tracks the pay items on the project and ensures that the change orders and estimates are correct. Photos and videos are an important documentation of the work before, during, and after. OHM Advisors will keep the photos and videos in house until final completion after restoration is accepted and then deliver them all in one packet along with the CDRs, record drawings, and other contact documents in one complete package.
4. Prepare record drawings of the substantial details that may have changed throughout the submittal process and the subsequent construction.

Deliverables:

- Record drawings
- Construction file packet including – approved record drawings (referenced above), approved submittals, Construction Daily Reports, the estimates, any change orders, an item history report, and the photos and videos documenting the work.

Task 3: Construction Surveying

Under this task, the team will perform construction staking and as-built survey. Specific work efforts include:

1. Project staking will include setting at least one benchmark in areas of proposed improvements. These will be used by both the contractor and field engineer to use to stake specific measures during construction. We have assumed one crew day for construction survey of the proposed project.

Deliverables:

- One bench mark
- Cut sheet for bench mark



The services outlined above will be performed on an hourly basis with a not to exceed budget of \$35,000.00. Upon your approval of this additional scope and fee, we will modify the CA/CE budget to accommodate this scope. In accordance with your request, Hubbell, Roth, & Clark, Inc. (HRC) and our project partners InSite Design Studio, Inc. (InSite) are pleased to provide this proposal for ongoing post project monitoring services for the Benz Creek, Huron Hills Golf Course, 5598.01 Drain Project. As required by your permit (WRP023197 v.1 - dated June 18, 2020), the following monitoring activities must be conducted in years one, three, and five following grading, planting, and the introduction of hydrology to the project site:

EGLE STREAM RESTORATION REQUIREMENTS:

1. Photographic Documentation
 - ≡ Set up permanent photo stations: document the restored stream, riparian buffer, each cross-section, and each in-stream structure.
 - ≡ Provide a map of the photo stations and label each picture with its location, date taken, and direction.
2. Stream Dimension and Profile
 - ≡ Survey the longitudinal profile and a minimum of 4 permanent riffle cross-sections and 4 permanent pool cross-sections.
 - ≡ Provide the bankfull width, depth, cross-sectional area, width to depth ratio, percent riffle, pool to pool spacing, pool max depth ratio, bank height ratio, and entrenchment ratio.
3. Stream Lateral Migration
 - ≡ Determine BEHI and NBS scores for all banks except along point bars or non-eroding riffles.
4. Sample Vegetation Plots
 - ≡ Determine the percent cover within the herbaceous layer at the end of each permanent cross-section (16 total).
5. Delineate Areas Without a Predominance of Native Vegetation
 - ≡ Determine any areas greater than 0.01 acre in size that contain bare soil or invasive species.
6. Determine Water Clarity
 - ≡ Inspect the site for oil, grease, man-made debris or any other contaminants.
7. Document Substrate Characteristics
 - ≡ Identify any areas of erosion and/or deposition within the stream bed.

8. Assess Stability and Performance of In-Stream Structures
 - ≡ Identify any areas of bank erosion, piping, undermining, end around, or other indication of instability.
9. Provide Written Summary of All Existing Data
 - ≡ Compare current data with that collected in previous monitoring years and the as-built survey and discuss the trends.
 - ≡ Identify all performance standards and whether each has been met.
10. Provide Written Summary of Problem Areas
 - ≡ Identify potential corrective measures, as needed.
11. Provide Documentation of Bankfull and Greater than Bankfull Events
 - ≡ Supply data, analyses, photos, etc.
12. Provide Any Additional Measurements Needed to Meet Performance Standards

Monitoring reports must cover the monitoring year from January 1 to December 31 and be submitted to EGLE prior to January 31 of the following year. After your review, HRC proposes to complete all the tasks listed above, as stated in the permit, during the appropriate years and submit the monitoring report to EGLE on behalf of Washtenaw County Water Resources Commissioner (WCWRC). HRC will also visit the site in years two and four to take additional photographic documentation and identify any obvious problems with the structures and vegetation. This will allow for any necessary corrective actions to be taken prior to the next monitoring year. Please note that the Year 1 effort is substantially higher to set everything up the first time.

The permit does not specifically mention any monitoring tasks for the treatment wetlands on the back half of the golf course.

Note: HRC will invoice on the time spent on the project including InSite's team. Budget adjustments will only be made after WCWRC written authorization. Services not covered include: invasive species removal or reseeding and corrective action design, construction, or oversight. Any follow-up maintenance activities would be administered separately.

In order to obtain the EGLE permit, WCWRC was required to submit a Preliminary Schedule of Maintenance Activities. It is HRC's understanding that WCWRC plans to be responsible for performing those activities or overseeing their completion outside of HRC's involvement.

To complete the monitoring requirements for five years, as stated in the permit, HRC proposes a total cost of **\$38,000.**
